TERMS AND CONDITIONS

These terms and conditions (“Terms”) describe the terms under which prospective students may apply for and participate in the training camp “Skating School of Switzerland Summer Camp 2018” organized by Special Figures SA that will take place in Champéry, Switzerland during the period July 22–August 5, 2018.

1 INTERPRETATION

In this document, the following words shall have the following meaning:

the “Student”: the person taking part in the camp or for whom admission is sought;

“You”: the person seeking admission for the Student, who must be either the Student him- or herself if above eighteen years of age, or his or her parent or guardian;

“Chaperon”: a student’s parent, guardian, or the person responsible for a student during the camp;

“We”, “Special Figures”, the “Organizer”: Special Figures SA, having its registered address at Chemin de Pro-de-Narre 19, 1907 Saxon, Switzerland;

the “Camp”: the training camp “Skating School of Switzerland Summer Camp 2018” organized by Special Figures SA;

the “Application”: all information transmitted to the Organizer about the Student regarding his or her application for the camp, including information submitted through the application form on the Website;

the “Website”: the website describing the Camp offering, available at www.skatingschool.ch.

2 ADMISSIONS

Registration for the Camp begins with Your submission of the application form. We may request some additional information to complete the Application. We will then review it and decide whether the Student will be admitted to the Camp. You will finally be notified of Our decision by email.

3 PRICE

The price of the Camp includes the tuition fee for the scheduled on-ice and off-ice lessons and the usage of the facilities during allocated times, including the ice time. Participants will also receive a complimentary welcome package upon their arrival.

Accommodation and meal plans can be ordered at a supplement to the price of the Camp.

4 ACCOMMODATION

The Palladium Hotel provides the accommodation. The price for the accommodation includes breakfast.

Students and/or their Chaperons may choose to share a room. The occupants of the room must be communicated to the Organizer at the latest a month prior to the beginning of the Camp.

5 MEAL PLANS

The meal plans are prepared by and served at the restaurant Café du Centre in Champéry. For each week, the meal plans start with dinner on the Sunday of arrival and lunch on the following Sunday.

We will try to accommodate students' food requirements, but cannot guarantee that a suitable offering will be available, in particular for students with allergies.

6 REPRESENTATIONS AND WARRANTIES

You represent and warrant that the information supplied in the Application is complete and rigorously correct.

7 WAIVER AND RELEASE

Acknowledging that participation in athletics carries with it a risk of physical injury, You agree that the Organizer, its agents, and its employees shall not be liable for any injury or damage, howsoever caused, resulting directly or indirectly from the Student's participation in the Camp at any time preceding, during, or after the Camp is in session and You hereby discharge the Organizer, its agents, and its employees from all actions, claims, and demands You or the Student may have for any such injury or damage.

You authorise that the Organizer has the right to use all photographs or videos taken of the Student during camp for advertising or promotional material.

8 INSURANCE

All students must be insured against the illnesses and the injuries that may occur during their participation in the Camp. Foreign students are required to obtain medical and accident insurance valid in Switzerland. The Organizer may request a proof of insurance coverage. You may contact Us for assistance in obtaining such insurance.

9 PAYMENT

To secure the Student's place in the Camp, the total price is due at the time of admission.

Payments must be made in Swiss francs by bank transfer to the account communicated to enrolled students. Bank fees incurred by the Organizer may be charged to You.

10 CANCELLATION

If You wish to cancel a registration for any reason, You must do so in writing to the Organizer. The registration may be cancelled before May 14, 2018; thereafter the outstanding amount becomes due and payable.

No refunds will be granted after May 14, 2018 for absences, transportation delays or withdrawals. Refunds will not be granted in the event that an act of war (declared or otherwise), strike/work stoppage, natural disaster or reasons beyond the control of the Organizer, disrupts or forces the cancellation of the Camp.

The Organizer reserves the right to cancel the camp at the latest on May 28, 2018. In such an event, the amount paid in advance shall be reimbursed within 30 days. The Organizer shall not be liable for any damages or costs resulting from a cancellation.

11 MISCELLANEOUS

A responsible adult must accompany students under the age of eighteen.

The Organizer reserves the right to make changes to the coaching team, the program of the Camp, the content of the lessons or their schedule, and the provider of the meals.

The Organizer reserves the right to dismiss, in its sole discretion and without notice or delay, students whose conduct, influence or behaviour is deemed unsatisfactory or detrimental to the best interests of the Camp or fellow students or who violates camp rules and regulations. No refunds will be granted in such an event.

12 APPLICABLE LAW AND JURISDICTION

These Terms and all matters arising out of or relating to these Terms shall be governed by the substantive laws of Switzerland, without regard to the conflicts of laws principles thereof.

Any disputes arising out of or in connection with these Terms shall be submitted to mediation in accordance with the Mediation Rules of the Swiss Chamber of Commercial Mediation. If an out-of-court settlement cannot be reached, any controversy, claim, or dispute between You and the Organizer arising out of or in relation with these Terms shall be subject to the exclusive jurisdiction of the ordinary courts of Canton Wallis, Switzerland.
